**FROSTBITE SERIES. WAIRERE (PHRF-A), RUMBLE (PHRF-B/C), and WIND DANCER (PHRF-NonSpin) took first in their respective fleets in Frostbite Race #4, the second race of the Series to be completed.** The optimum racing conditions yesterday made up for the previous two fruitless Sundays, where there was either too much wind or none at all. The 17 boats on the course raced from just over 9nm to under 7nm. All finished the race in good time and were in no later than 3pm-ish, having conquered the day. . . regardless of a challenging current and a crab pot display that put the number of lights in any Rockefeller Center display to shame. **Changes off the Chesapeake Avenue (Hampton) shoreline near the sand barge mooring.** A new mooring area has been established along Chesapeake Avenue (Hampton) between the cross streets of LaSalle Ave. and Powhattan Pkwy. Southern Bay Racer, Alan Bomar sent this depiction. Anyone sailing in the area will have to pay close attention. As of mid-afternoon last Monday, all 6 white floats with blue stripe were in place and a barge was being hung off one. It is safe to expect constant change in the pace in barge traffic.
