**Answer to RR Quiz Question:** A and E. are both correct. A - If you are going to hit something, make it an orange inflatable. Just don't drag it anywhere! E - When any part of your hull, crew, or equipment crossed the finish line in the direction from the previous mark, you were finished. However, you weren't **done.** You are still racing until you clear the finish line and marks. You failed to do that, since you hit the mark. To exonerate yourself, you must follow Rule 31.2 by getting clear of other boats (on either side of the line) and doing a one-turn penalty. Then you must get back to the course side of the line and finish - again. By the way, if you do not exonerate yourself, you may be protested by anyone who saw it happen, i.e. another boat or the race committee.

**MURPHY'S LAW:** Yikes! a close encounter with a channel marker! That leads to an even closer encounter with the fiberglass guy. Now, that's a budget buster! /S/ Murphy the Racing Beagle, the sailing spirit in us all.
