**SCHIEHALLION is overall winner in FBYC Closing Day Race.** Skipper **Brad Miller** and crew were first to cross the finish line in the annual Fishing Bay Yacht Club closing day staggered start (pursuit) race Saturday. Two other PHRF C boats sailed their way to the podium, *Morningtide* (**Collins**) finished 2 seconds behind *Schiehallion*, and 2 seconds later, third place *Prophet* (**Noel Clinard**) crossed the line. **Mike Dale's Juggernaut** was the first PHRF B boat to finish (4th overall in spinnaker fleet) and **Glenn Doncaster** in *Nanuq* was the first PHRF A boat to finish ((6th overall in the spinnaker fleet). The PHRF Non-Spin fleet was scored separately from the spinnaker boats and *Red Sky* (**Anderson**) finished first among non-spins, with *Last Boat II* (**Frank Murphy**) second and *Gray Eagle* (**Cross**) third.
